

Immigration

Our fee arrangements

The fees quoted below are estimates and may change depending on your personal circumstances. We can be more specific once we have all of the necessary information about your case.

The prices indicated below as 'from' mean that the quoted fee is the minimum amount for each application, but the full amount could be higher. Please treat all amounts set out below as indicative of the likely fees rather than the guaranteed final price.

Where a matter cannot be completed e.g. because of lack of documents, we will charge you for the time spent on any work we have done at our hourly rate of £300 per hour, plus VAT of £60.

Consultations

Services

We only accept instructions from individuals for Tier 1 Investor visas or from those workers being sponsored as Skilled Workers or via the Intra-company Transfer route.

Individuals applying for a Tier 1 Investor visa, Skilled Worker visa or Intra-company visa must also pay the NHS Surcharge of £624 per year.

A discount of £55 applies to some of the above categories for nationals of Austria, Belgium, Croatia, Republic of Cyprus, Czech Republic, Denmark, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Luxembourg, Malta, Netherlands, North Macedonia, Norway, Poland, Portugal, Slovakia, Spain, Sweden or Turkey.

Disbursements

All disbursements will need to be paid for separately in addition to the fees for our services.

You will incur the Home Office application fees, as listed above.

Employers issuing a certificate of sponsorship will incur a fee of £199 for each certificate.

Employers will also have to pay the Immigration Skills Charge which costs between £364 and £1,000 for the first 12 months of any visa and between £182 and £500 for every subsequent 6 months.

Individuals will also incur the NHS Surcharge of £624 per year of the visa, for example for a 3 year visa the NHS Surcharge would be £1,872.

There is no VAT payable on any of these fees.

What isn't included?

You may incur additional costs for matters that fall outside the scope of our fees, such as:

- Confirmation from NARIC that any overseas qualifications meet the minimum qualification requirements for your visa;
- Undertaking an English language assessment to show that you can read, write, speak and understand English to at least level B1 on the CEFR scale; and
- Interpreting and translation services for any documents that need to be translated into English which fall outside the scope of our fees.

Costs on Account

We require an initial payment of at least half of the fee at the start of your matter and the remainder before your application is submitted. All disbursements must be paid before they are incurred by us.

Processing times

Whilst we will endeavour to deal with your matters as promptly as possible and provide you with updates. Provided we receive the information and documents we need from you promptly, it usually takes 2-4 weeks from the time of instruction for us to submit your application.

Thereafter, we are unable to influence Home Office decision making times and therefore cannot guarantee how long it will take for them to process your application. The Home Office publish their current processing times on their Home Office website:
